WHEREAS, the Annual Budget for Monroe Township FD No. 1 (the 'Fire District') for the fiscal year beginning January 1, 2022 and ending December 31, 2022 has been presented before the Board of Commissioners of the Fire District at its open public meeting of December 8, 2021; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$2,754,613.00 which includes an amount to be raised by taxation of \$2,676,648.00 and Total Appropriations of \$2,754,613.00; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on December 8, 2021 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2022 and ending December 31, 2022 is hereby approved; and

As in the past years, the Commissioners developed the 2022 Budget after carefully considering all factors and related costs necessary to maintain firefighting facilities. Their intent was to minimize any increases in the tax rate while completing building landscaping and signage and providing continued excellence in volunteered fire protection services.

3. **Explain any variances over +/-10% for each line item.** Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item.

Appropriations

- 1) Decrease in election expenses and dues as new state regulation and increased the amount of absentee ballots to be mailed to voters, however, actual fees were less than anticipated for 2021.
- 2) Increase in other operations & maintenance expense: volunteer firefighters increased availability thus firehouse is continuously occupied which costs more to run and maintain, completion of building landscaping, signage etc. as well as increasing firefighting services as the commercial/residential area continues to continuously develop.
- 3) Decrease in confined space & rescue equipment as a bulk of the equipment was purchased in the prior year and will last for multiple years.
- 4) Increase in tools & equipment to replace broken equipment and purchase a new holmatro extraction equipment.
- 5) Increase in radios and bases per an annual payment by the township licensing agreement for all districts to which converted to all band radio system in 2021.
- 6) Increase due to needed building signage.
- 7) Decrease in fire prevention expenses to reflect the revenues offset with appropriations for 2022.
- 8) Increase in LOSAP contribution as 32 members qualified for LOSAP contributions. Over the course of the past three years from 2018 – 2020 we have had the following qualifying members 25, 25 and 32, respectively. Since the start of the pandemic there has been an increase in volunteer fire fighter's availability and in the amount of volunteers that have joined and started training in the volunteer department. Thus, more volunteers are expected to meet qualification for 2022's LOSAP contribution.
- 9) Decrease in capital appropriations due to the prior year down payment of SCBA airpack was made in 2021. Remaining item is starting

If Unrestricted Fund Balance is reduced by more than 10%, explain the projected impact on the following year's budget.

In order to comply with the statutory and state administrative regulations, which requires the Fire District Budget be introduced and adopted within a specified time period, we have used the "initial" (not final) ratable figure provided by the Township's Tax Assessor in our calculations. Based on these calculations, the tax rate will increase from \$.1299 to \$.1350 per \$100 of assessed valuation.

- 1) The Fire District has committed to using \$47,000 of its unrestricted fund balance to offset its 2022 budget.
